Mr. Wong, aged 51, has more than 21 years of experience in sales, marketing and general management. Mr. Wong joined the Group in 1982. He holds a Bachelor of Science degree in Engineering and a Master degree in Business Administration. Mr. Wong was appointed as the Executive Director and the General Manager of the Company on 23rd June, 1997 and 1st February, 1999 respectively. He is responsible for the strategic planning and general management of the Group. He is also a director of various members of the Company's Group.

Mr. Wong did not hold any directorship in other listed public company in the last three years. Mr. Wong does not have any relationship with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company. At present, Mr. Wong holds personal interests of 9,696,072 Shares in the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Mr. Wong is not appointed for a specific term except that he is subject to retirement by rotation and re-election in accordance with the Company's articles of association. The Directors are not aware of any other matter relating to the re-designation of Mr. Wong Yiu Ming as an Executive Director and Chief Executive Officer that needs to be brought to the attention of the Shareholders.
