Election of Means of Receipt of Corporate Communications

Pursuant to Rules 2.07A and 2.07B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") and the articles of association of Cosmos Machinery Enterprises Limited (the "**Company**"), the Company intends to ascertain your election of means of receipt of future corporate communications issued by the Company (the "**Corporate Communication**(s)"), which include any document(s) issued or to be issued by the Company for the information or action of its shareholders, including but not limited to (a) the directors' report, its annual accounts together with a copy of the auditors' report and, where applicable, its summary financial report; (b) the interim report and, where applicable, its summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular; and (f) a proxy form.

You may choose:

If the Company does not receive a duly completed and signed reply form on or before 4 August 2023, until you inform the Company c/o the Share Registrar by serving reasonable prior notice of not less than five clear business days in writing by mail or by email, you will be deemed to have consented to receive the Website Version only for all future Corporate Communications instead of Printed Version.

You are entitled to change your means of receipt of Corporate Communications at any time by serving reasonable prior notice in writing by mail or by email to the Company c/o the Share Registrar. If you have chosen to receive the Website Version of all future Corporate Communications but for any reason have difficulty in accessing to the Company's website, the Company c/o the Share Registrar will, upon receipt of your written request, promptly send a Printed Version to you free of charge.

Please note that the Printed Version of Corporate Communications will be available from the date of despatch from the Share Registrar on request, and the Website Version will also be available on the websites of the Company at http://www.cosmel.com and the Stock Exchange at https://www.hkexnews.hk.
